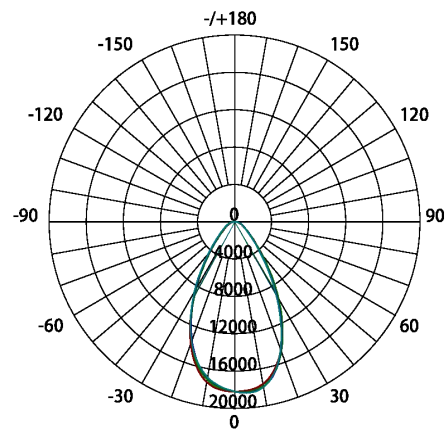
12° light distribution



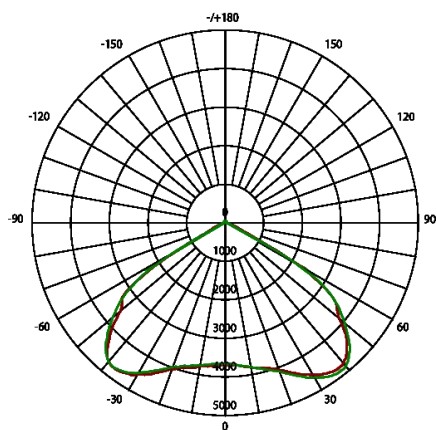
25° light distribution



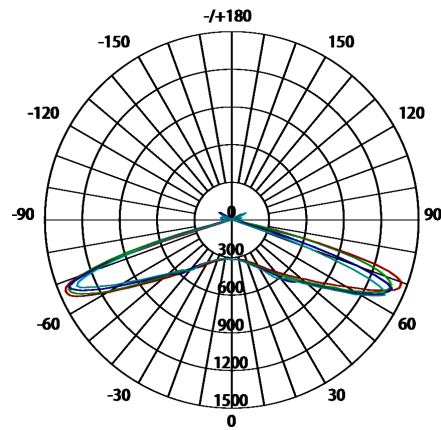
40° light distribution



60° light distribution



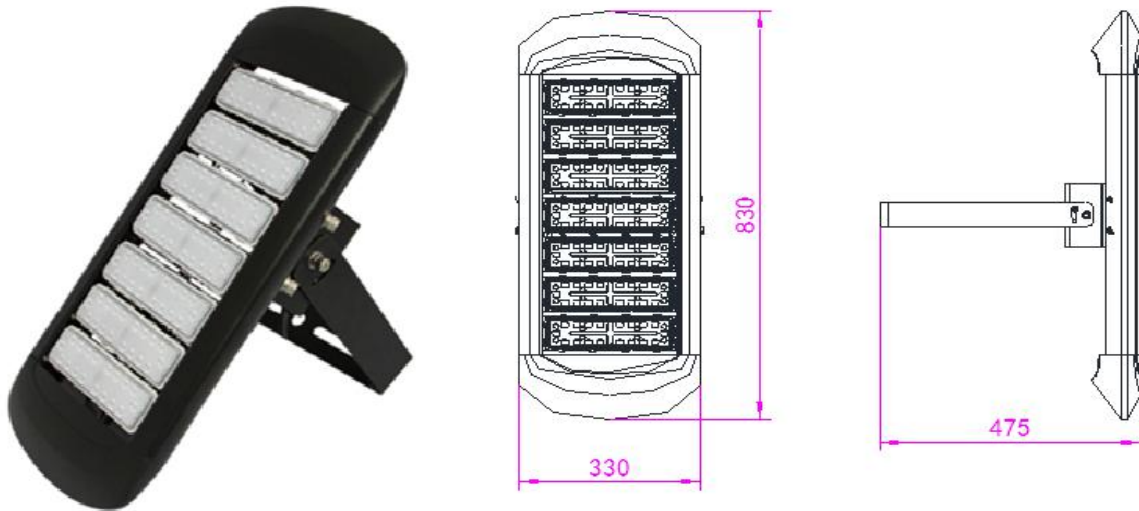
90° light distribution

6-3-2 Low temperature storage.

Externals, the structure, operation, and the performance must meet when you do the performance assessment after 2H is left at the normal temperature after 246H is left at -10°C.

6-3-3 High temperature operation

Externals, the structure, operation, and the performance must meet when it confirms the operation in the same atmosphere after 96H energizes by the voltage rating of 40°C rated frequency, and the performance assessment is done after 2H is left at the normal temperature.

6-3-4 Low temperature operation

(a) Starting up

Operation must meet when confirming the cold-start operation in the same atmosphere in the voltage rating of the rated frequency after 24H is left at 5°C.

(b) Continue operation

Externals, the structure, operation, and the performance must meet when it confirms the operation in the same atmosphere after 96H energizes by the voltage rating of -10°C rated frequency, and the performance assessment is done after 2H is left at the normal temperature.
